RUNNING START FEE WAIVER PROGRAM

Students who are unable to pay their fees due to financial hardship are welcome to apply for a fee waiver.

The waiver provides:

- Coverage of fees for college-level classes
- Vouchers towards the cost of textbooks (exact amount varies by quarter)

Students who receive a fee waiver are still responsible for:

- Self-support class fees (certain music and art classes)
- Fees for courses below 100-level
- Transportation
- Remaining textbook costs
